1. All expenses associated with transporting the mare from Rolling Oaks Farm in Elgin IL is the responsibility of the high bidder. Bidder should contact the mare owner to get additional details before bidding.
2. Mare is currently in foal to Pajou. Should it be necessary there is a LFG that would allow this mare to be rebred in 2007. The following terms apply. If Pajou is to be used, mare must return to Rolling Oaks to be bred AI. If Donaudeen is used the breeding can be transported cooled semen or on farm AI. Any additional cost incurred in rebreeding the mare is the high bidder's responsibility.
3. It is understood that this is a broodmare and that she is not broke to ride.
4. If you are attending the ATA Convention in Ohio the deadline for bids is Saturday night, **November 4<sup>th</sup>**, at the Banquet.
5. If you do not plan on attending the Convention, your bid and payment must reach Sue Pitzer no later than **October 29, 2006**. Any bids arriving after that time will not be counted.
6. Winner will be announced at the Banquet and posted on the ATA 2006 convention website by November 7<sup>th</sup>.
7. There is a minimum bid of \$3000 that must go to Rolling Oaks Farm. Any monies above that amount will be divided 50/50 between Rolling Oaks Farm and the ATA.
8. Payment must accompany this signed bid sheet for bid to be considered. Enclose check or fill out credit card information below.
